REQUESTION THE COUNTY COURT OF BROOKE COUNTY.

WEST VIRGINLA TO INCLUDE THE CORPORATE LIMITS OF THE VILLAGE OF BEECH BOTTOM. BROOKE COUNTY. WEST VURGINLA. IN A CERTAIN COUNTY WIDE PUBLIC SERVICE DISTRICT FOR THE PURPOSE OF SAID PUBLIC SERVICE DISTRICT TO COLLECT. TREAT, PURWY, DISPOSE OF LIQUID OR SOLED WASTE, SEWAGE OR INDUSTRIAL WASTE FROM THE VILLAGE OF BEECH BOTTOM.

Whereas, the Village of Beech Bottom is a Municipal Corporation located within the confines of Brooke County, West Virginia, and;

Whereas, the said Village is without treatment facilities and adequate collection facilities for the collection, treatment, purification and disposal of liquid or solid waste sewage or industrial waste; and

Whereas, the Common Council of the Village of Beech Bottom has been informed by the Environmental Protection Agency of the United States Government and the West Virginia Department of natural Resources, that the said waste as aforesaid should be treated; and

Whereas, the said Village of Beech Bottom is unable to acquire financing form any United States Governmental Agency or from any Agency of the State of West Virginia because of certain feasibility studies; and

Whereas, the County Court of Brooke County, West Virginia, on the ____ day of _____ , 1975, formed a Public Service District in the County of Brooke for the purpose of treating sewage; and

Whereas, the Common Council of the Village of Beech Bottom is desirous of giving up any rights granted it by the Statutes of the State of West Virginia for Sewage Treatment and entering into the Public Service District for Brooke County, West Virginia, pursuant to Chapter 16, Article 13-A of the West Virginia Code as amended.

Now, therefore, be it ordained by the Common Council of the village of Beech Bottom, that they hereby surrender any rights which they may have by virtue of the Statutes of the

State of West Virginia in regard to the treatment of sewage, solid waste and other waste material, and that they request the County Court of Brooke County, West Virginia to permit said Village of Beech Bottom to become part of the Brooke County Public Service District and that they further request that the said County Court of Brooke County, West Virginia file all necessary notices of publication, hold all public meetings as required by the Statutes of the State of West Virginia, accept the Village of Beech Bottom as a part of the Brooke County Public Service district.
